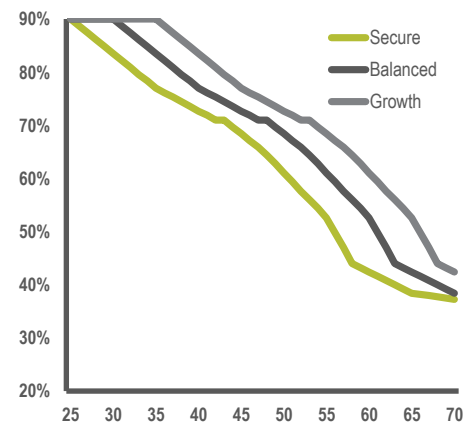
### YOUR TRAJECTORY PORTFOLIO
